The appointed evaluator will be responsible for:

- Designing and delivering a light-touch but meaningful evaluation framework.
- Reviewing project documentation, data, and reports.
- Conducting interviews or surveys with a sample of participants, partners, and delivery staff.
- Producing an interim summary (by November 2025) and a final evaluation report (by February 2026).
- Providing any key findings or data required for funder reporting by March 2026.

- Evaluation plan (August 2025)
- Midpoint reflection summary (November 2025)
- Final report (February 2026)
- Support for final project reporting (March 2026)

Fee

The total fee for this work is up to £4,000 inclusive of VAT and expenses. Payments will be phased in line with agreed milestones.
